

## ANNOUNCEMENT

Within the investor protection framework and following CySEC multiple public warnings Boson Alfa Ltd (hereinafter the «Company») warns its existing and potential clients regarding individuals and legal entities that:

### **1. Impersonate regulated entities and authorised persons of such entities while they are not**

Please pay attention that official name of our company is **Boson Alfa Ltd** (shortly **Boson Alfa**) and the registered trademark is **Boson Alfa Asset Management** with the graphic sign how it appears on this website.

The official domain of our Company is [www.bosonalfa.com](http://www.bosonalfa.com).

Any other versions of the name, trademark and domain belong to unregulated entities that fraudulently use the name of our Company.

Except the name and domain of our Company the unregulated entities may use any other name/domain or similarity with the names/domains of regulated entities listed on the website of CySEC.

On its website CySEC listed the names and domains of regulated entities with granted authorization for the provision of investment services and/or the performance of investment activities, as provided for in Article 5 of Law 87 (I)/2017 (Section «Regulated Entities»).

Except that, list of individuals authorised by CySEC after relevant examination can be found on CySEC website (Section «Certifications»).

### **2. Impersonate CySEC representatives while they are not**

Boson Alfa Ltd would like to pay attention that CySEC never sends unsolicited correspondence to investors or members of the public, nor does it ever request any personal data, financial or otherwise. CySEC has no authority or jurisdiction to collect fees for any purpose from individual investors, nor does it have authority to appoint anyone to do so on its behalf.

Such cases occur often and may be part of a sophisticated online campaign that seeks to defraud investors. Typically, such scams may have the following characteristics:

- Individuals claim to be CySEC officers, appointed representatives of CySEC (e.g. legal advisors), other Cypriot supervisory authorities (e.g. Central Bank of Cyprus) and/or bank representatives appointed by CySEC;
- These emails appear genuine when they are not – they carry the name, address, official stamp and logo of CySEC and fraudulently copy CySEC officials' signature.
- The fraudsters then make false promises to assist investors with compensation for potential damages in connection with dealings they have had with sanctioned firms (typically online trading firms offering speculative investment products).
- Through this engagement, the fraudsters illegally obtain personal information including telephone records.
- In some cases, investors are then called via telephone in relation to email correspondence.

What you should do if you are unsure about unsolicited correspondence?

- 1. Do stay alert:** remain vigilant regarding any unsolicited communication from CySEC. If you are confused why the regulator is contacting you, that is because it is likely not.
- 2. Don't provide personal information:** CySEC will never ask you for money or personal financial information.
- 3. Refrain from giving money** to anyone who claims any or all of the above, or similar.
